

**Village of Sherman –Regular Board Meeting**

Deputy Mayor Gratto called the meeting to order at 7:10 pm.

**RESOLUTION #1:** On motion made by Trustee Higginbotham and seconded by Trustee Reyda to accept the October 4th, 2017 board meeting minutes as submitted.

**JAY IRWIN:**

- **DIP SYSTEM:** Mr. Irwin stated that the Direct Inline Pumping System is set to ship from Kansas on Thursday, November 2<sup>nd</sup>, and should reach us in two weeks. He added that Mr. Zarbo (Barton and Loguidice) recommended that the acting mayor or new mayor submit a letter of recommendation to the State for funding.
- **REMOTE MONITORING SYSTEM:** Mr. Irwin proposed replacing the DFT alarm system which has monthly costs adding up to roughly \$350-\$450 per year. The new remote monitoring system has a once off cost of \$3120 and would benefit both the sewer and water departments. The new system would notify both department heads anytime the status of the generator changed, informing them if there is a problem and if they need to be present on-site after hours.

**RESOLUTION #2:** On motion made by Trustee Reyda and seconded by Trustee Higginbotham to approve purchasing the Remote Monitoring System for \$3120 and share the cost between the wastewater and water department.

- **STREETS:** Mr. Crane said that the leaves have been picked up and they are preparing for the snow.
- **WATER:** He is working on a leak on Church Street.
- **ACCOUNTS:** Mrs. Watson filled her pool and has given us the readings as required. Mr. Crane asked for approval to reverse the sewer chargers on this pool water. Clerk Ramm also had an account query for Fred Gable. Although his account has been closed for two years there is still an outstanding penalty amount of \$14.06.
