ASSESSOR'S REPORT - Oct/Nov

Oct; 2021

- There were 5 deeds recorded in August.
- I Attended the Annual Assessor Conference. I have successfully completed my training requirement for continuing education for Assessor certifications.
- There have been several property owners with complaints regarding their STAR Credit/STAR exemption. In 2016, NYS DTF took over the administration of these exemptions, and I must follow their determinations for approvals and denials. I cannot circumvent these destinations, and property owners must now reach out to NYS Tax & Finance themselves if there has been an error. I wish I had the ability to be of more assistance to our property owners, but I cannot...

Nov. 2021

- There were 6 deeds recorded in September.
- On October 25th, Governor Hochul signed a bill into law effectively closing the loophole that has cost many towns, cities, and villages millions in taxes. The "Dark Store" bill prohibits the use of comparable sales of closed, out of business big box stores rather than thriving national chain stores. The NYSAA legislative committee has been working diligently with Assemblyman Kenneth Zebrowski and Senator James Gaughran to eliminate "dark store" theory. Their sponsorship of this important bill was key to its passage in both chambers and being signed into law. Big box stores will now pay their fair share of taxes throughout New York State.
- Exemption Renewal application will be mailed by the end of November. Property owners have until March 1, 2022 to file their renewal in the office.
