### **SUPERVISOR REPORT**

- Supervisor Persons reported that he had met with Brenda Ireland in regards to the 2023 insurance. The biggest issue in the policy was the Clerks building. The insurance company had put a \$600,000 price on the building. Brenda was able to work and get it down to \$535,000. Brenda is looking into what the cash value would be for the building. Further discussion will be held at the December Board meeting.
- Supervisor Persons shared with the Board about 1<sup>ST</sup> Amendment Audits and how it is effecting the work place along with ideas of how to protect the employees.
- Information on the Chautauqua County Tea Party was handed out to board members for them to read and will be discussed more at the Dec. 8<sup>th</sup> meeting.
- The Information of The Town of Sherman's Opposition to New York States Actions Restricting the 2<sup>nd</sup> Amendment Rights was presented to the Town Board as follows:

# TOWN OF SHERMAN OPPOSITION to New York State Actions Restricting 2<sup>nd</sup> Amendment Rights

**WHEREAS,** On July 1<sup>st</sup> ,2022 Kathy Hochul, the Governor of New York State Signed into law the Concealed Carry Improvement Act (CCIA) that was drafted in close collaboration with the New York State legislature; and

**WHEREAS,** the Governor and the legislature surreptitiously rushed the CCIA through passage under a message of necessity and during an 'extraordinary session' bypassing the traditional rules and procedures of the legislature; and

**WHEREAS**, many of the provisions of the CCIA that went into the effect on September 1<sup>st</sup>, 2022 place unprecedented and overly restrictive conditions on applying for, obtaining, utilizing, maintaining and recertifying a conceal carry permit for personal protection and other legal uses that are protected by the Constitution of the United States; and

**WHEREAS,** The New York State Sheriffs' Association recognized these new laws as "punitive licensing requirements that aim only to restrain and punish law-abiding citizens who wish to exercise their Second Amendment rights"; and

WHEREAS, The Town of Sherman has a strong history of upholding the Constitution of the United States and supporting lawful citizens in their pursuit of 'Life, Liberty and the Pursuit of Happiness' and that The Town of Sherman recognizes that these are essential elements of the freedoms that we enjoy as United States citizens; and

**WHEREAS**, the Sherman Town Board also recognizes and respects the inherent right of our private law abiding citizens to 'keep and bear arms' as a means of protecting their property, self and family; therefore

**LET IT BE KNOWN,** that the Sherman Town Board is vehemently and with full resolve opposed and request the immediate repeal of the CCIA as being unjust, ineffective, vague, and an impingement on Second Amendment rights; and be it further

**MOVED,** That the Sherman Town Clerk is hereby directed to forward copies of this motion to New York State Governor Kathy Hochul, State Senator George Borello, Assemblyman Any Goodell, the New York State Association of Towns, and all others deemed necessary and proper.
