Councilman James Higginbotham made the motion, seconded by Councilman Howard Crump to appoint Brant Henning as Councilman for the Sherman Town Board effective June 1, 2022.

 Supervisor Persons had several complaints on the condition of the Town Cemeteries. Supervisor Person, Councilman James Higginbotham, Highway Superintendent Sweatman and Cemetery Sexton Michael Courtney met to discuss the situation and came to agreement that the Highway Department assist at the cemetery in the months of May and before Sherman Day in Aug.

#### **RESOLUTION #25**

Supervisor Mark Persons made the motion, seconded by Councilman Howard Crump that The Town of Sherman Highway Dept. will assist at the Sherman Cemeteries in the month of May and the week before Sherman Day in Aug.

- Resident Steve Swan contacted The Town of Sherman in regards to the possibility of the town's abandonment of the Barcelona Rd. Supervisor Persons has contacted the town attorney and will report back at the July meeting as to what attorney recommends.
- Supervisor Persons confirmed that both the Town and Village of Sherman has monies budgeted to cover the 2022 Youth Programs.
- Dog Control Officer Kelly Thornton has been approved by NYS Ag and Markets to shelter seized dogs in the proper facilities at her property. Kelly is asking that the Town of Sherman to enter into the following Dog Sheltering/Lease Agreement with her:

#### DOG SHELTERING AGREEMENT

THIS AGREEMENT, made this second day of **June 2, 2022** by and between **Kelly Thornton**, hereinafter referred to as the SHELTER and the **Town of Sherman**, hereinafter referred to as the MUNICIPALITY;

#### WITNESSETH:

WHEREAS, the MUNICIPALITY wishes to comply with the New York State Agriculture and Markets law as it pertains to seized dogs and;

**WHEREAS,** the **SHELTER** has personnel, animal shelter and proper facilities for the care and disposition of seized dogs in violation of the New York State Law or other ordinances, or seizure by the **MUNICIPALITY** for other violations:

**NOW, THEREFORE,** the MUNICIPALITY and the SHELTER agree as follows:

- 1. The SHELTER, agrees to hold seized dogs in accordance with the New York State Codes, Rules, Regulations, Title 1, Part 77, Standards for the Care of Seized Dogs.
- 2. The SHELTER shall release seized dogs as set forth in Article 7, of the Agricultural and Markets Law, Section 118. The SHELTER will complete all Seizure and Disposition Reports and will provide a copy to the municipal Fiscal Officer monthly.
- 3. It is agreed that any seized dog is the responsibility of the MUNICIPALITY until such dog is redeemed, adopted, or euthanize. However, the FINANCIAL RESPONSIBILITY OF THE MUNICIPALITY shall end when such dog is transferred to the SHELTER.

- 4. This agreement becomes effective upon receipt of a signed agreement and shall be for a term of one (1) year from the date of execution, and shall be automatically renewed annually unless either party gives notice to the other party of its intent not to renew the agreement at least thirty (30) days prior to the end of the contract term. However, in addition, either party may terminate this agreement at any time, or for any reason, upon giving the other party thirty (30) days' notice of such cancellation. Notice shall also be provided to the New York State Department of Agriculture and Markets.
- 5. No amendment of modification of this agreement shall be effective until executed in writing by the parties thereto.

**IN WITNESS THEREOF,** said MUNICIPALITY and the SHELTER have caused their signatures to be signed, thereunto duly authorized all as of the day and year first above written.

#### SHELTER LEASSE AGREEMENT

# THIS LEASE AGREEMENT, made this 2<sup>nd</sup> day of June, 2022, between the <u>TOWN</u> OF SHERMAN and KELLY THORNTON

Will continue for one (1) year from the above date and shall be automatically renewed annually unless either party give notice to the other party of its intent not to renew the agreement at least thirty (30) days prior to the end of the lease term.

**TOWN OF <u>SHERMAN</u>** will lease 3 dog kennels to be used by the **DOG CONTROL OFFICER (DCO)** while performing his/her duties for the **TOWN OF <u>SHERMAN</u>**. These kennels will also be used for rabies containment quarantine.

In exchange for the use of said space, the **TOWN OF <u>SHERMAN</u>** will provide the necessary funding to maintain said space in compliance with New York Department of Agriculture and Markets regulation.

**IN WITNESS THEREOF,** said **TOWN OF <u>SHERMAN</u>** and the **SHELTER** have caused their signatures to be signed, thereunto duly authorized all as of the day and year first above written.
